


RESOLUTION 15-01

Subject: Bid for Rye Grass Seed

Staff advertised bids for the purchase and application of 16,000 pounds of 3 way perennial blend rye grass seed for the Parks and Recreation Department. Two bids were received. One bid from Kelly Seed did not include dry spray application. Staff recommends going with the lowest responsive bidder Southeastern Turf Grass & supply in the amount of \$24,377.50. The Parks and Recreation budget can sufficiently cover this expense. A suggested motion is provided should you choose to award it.
